

The Vancouver City Council has identified the Van Mall North area (see map on opposite side) as a potential area for annexation. It is located in Vancouver's Urban Growth Area (UGA), was identified as an area ready for annexation by the City and County in the Annexation Blueprint Plan (2007), and was slated for annexation in 2008 before it was halted by the recession. Van Mall North is already served by City of Vancouver water, sewer and emergency fire services. Council has asked staff to conduct public outreach and prepare an analysis of the feasibility of providing all City services to this area.

## PROJECT TIMELINE

Presentation and information sessions at neighborhood association meetings, resident meetings and a community open house. Regular project updates via email, social media and the City website.
- **April – Sept. 2016 | Identification of utility covenant signatures**

Staff provided an update on findings related to annexation to date; Council identified Van Mall North as a potential annexation area.
- **June- October, 2016 | In-depth analysis of proposed annexation area**
- **August 24, 2016 | Community Open House, Walnut Grove Elementary School, 5pm-8pm**
- **November 2016 | City Council Workshop**
- **TBD 2017 | City Council Meeting**  
Public hearing on proposed annexation boundary

## METHOD OF ANNEXATION

State Law authorizes several methods of annexation. The City will use the sixty percent petition annexation method, which means the City must have signatures on a petition to annex from the owners of at least 60% of the property value in the annexation area. The City has already obtained a significant number of petition signatures via existing utility covenants.
