COMES NOW the Prosecuting Attorney for Clark County, Washington, and does by this inform the Court that the above-named defendant is guilty of the crimes committed as follows, to wit:

**COUNT 01 - BURGLARY IN THE SECOND DEGREE - 9A.52.030**

That she, MISTY MAY RAYA, AKA MISTY MAY GAMBLE, MISTY MAY SEAMAN, MISTY M MARQUEZ, in the County of Clark, State of Washington, on or about June 1, 2021, with intent to commit a crime against a person or property therein, entered or remained unlawfully in the building of Public Storage, located at 7601 NE 5<sup>th</sup> Avenue, Vancouver, Washington ; contrary to Revised Code of Washington 9A.52.030(1).

**COUNT 02 - BURGLARY IN THE SECOND DEGREE - 9A.52.030**

That she, MISTY MAY RAYA, AKA MISTY MAY GAMBLE, MISTY MAY SEAMAN, MISTY M MARQUEZ, in the County of Clark, State of Washington, on or about June 2, 2021, with intent to commit a crime against a person or property therein, entered or remained unlawfully in the building of Public Storage, located at 7601 NE 5<sup>th</sup> Avenue, Vancouver, Washington ; contrary to Revised Code of Washington 9A.52.030(1).

**COUNT 03 - BURGLARY IN THE SECOND DEGREE - 9A.08.020(3) /9A.52.030**

That she, MISTY MAY RAYA, AKA MISTY MAY GAMBLE, MISTY MAY SEAMAN, MISTY M MARQUEZ, together with another, to-wit: BRIAN NEAL CLEMENT, in the County of Clark, State of Washington, on or about June 3, 2021, with intent to commit a crime against a person or property therein, entered or remained unlawfully in the building of Public Storage, located at

1 7601 NE 5<sup>th</sup> Avenue, Vancouver, Washington; contrary to Revised Code of Washington  
2 9A.52.030(1) and/or was an accomplice to said crime pursuant to RCW 9A.08.020.

3 **COUNT 04 - THEFT IN THE FIRST DEGREE - 9A.56.020(1)(a) /9A.56.030(1)(a)**

6 and June 3, 2021 did wrongfully obtain or exert unauthorized control over the property or  
7 services of another, to-wit: miscellaneous property including but not limited to ammunition, tires,  
mechanical watches, PVS 14-night vision Monocular, having a value exceeding \$5000.00, with  
intent to deprive Tommy L. Huynh, the true owner thereof, of such property or services; contrary  
to Revised Code of Washington 9A.56.020(1)(a) and 9A.56.030(1)(a).

8 **COUNT 05 - UNLAWFUL POSSESSION OF A FIREARM IN THE SECOND DEGREE -**  
9 **9.41.040(2)(a)**

10 That she, MISTY MAY RAYA, AKA MISTY MAY GAMBLE, MISTY MAY SEAMAN, MISTY M  
11 MARQUEZ, in the County of Clark, State of Washington, on or about or between June 1, 2021,  
12 and June 3, 2021, after having previously been convicted in this state or elsewhere, of the crime  
of Identity Theft and/or Forgery in the First Degree and/or Felon in Possession of a Firearm, in  
the State of Oregon, did knowingly own or have in her possession or control a firearm, to-wit:  
multiple firearms; contrary to Revised Code of Washington RCW 9.41.040(2)(a)(i).

13 **COUNT 06 - IDENTITY THEFT IN THE SECOND DEGREE - 9.35.020(3)**

14 That she, MISTY MAY RAYA, AKA MISTY MAY GAMBLE, MISTY MAY SEAMAN, MISTY M

Tommy L. Huynh, with the intent to commit or to aid the commission of any crime; contrary to  
Revised Code of Washington 9.35.020(3).

18 **COUNT 07 - IDENTITY THEFT IN THE SECOND DEGREE - 9.35.020(3)**

19 That she, MISTY MAY RAYA, AKA MISTY MAY GAMBLE, MISTY MAY SEAMAN, MISTY M  
20 MARQUEZ, in the County of Clark, State of Washington, on or about June 3, 2021, in a  
21 separate and distinct act different from that alleged in count 6, did knowingly obtain, possess,  
use or transfer a means of identification or financial information of another person, to-wit:  
Tommy L. Huynh, with the intent to commit or to aid the commission of any crime; contrary to  
Revised Code of Washington 9.35.020(3).

22 **COUNT 08 - THEFT OF A FIREARM - 9A.08.020(3) /9A.56.300**

23 That she, MISTY MAY RAYA, AKA MISTY MAY GAMBLE, MISTY MAY SEAMAN, MISTY M  
24 MARQUEZ, together with another, in the County of Clark, State of Washington, between  
25 June 1, 2021, and June 3, 2021. did wrongfully obtain or exert unauthorized control over a  
26 firearm, to-wit: an Interarms AK-47 rifle, with intent to deprive Tommy L. Huynh, the true owner  
thereof, of such property; contrary to Revised Code of Washington 9A.56.300(1) and/or was an  
accomplice to said crime pursuant to RCW 9A.08.020.

27 **COUNT 09 - THEFT OF A FIREARM - 9A.56.300**

28 That she, MISTY MAY RAYA, AKA MISTY MAY GAMBLE, MISTY MAY SEAMAN, MISTY M


