COMES NOW the Prosecuting Attorney for Clark County, Washington, and does by this inform the Court that the above-named defendant is guilty of the crimes committed as follows, to wit:

COUNT 01 - RENDER CRIMINAL ASSISTANCE IN THE FIRST DEGREE - 9A.76.070(1)(2)(a)

That he, ABRAN RAYA LEON, in the County of Clark, State of Washington, on or about July 23, 2021, with the intent to prevent, hinder, and delay the apprehension of Guillermo Raya Leon, who had committed or was being sought for a class A felony or for murder, and knowing that such person had committed a crime or was being sought for commission of a crime did harbor and conceal such person, and/or warn such person of impending discovery and apprehension, and/or provide such person with money, transportation, disguise, and other means of avoiding discovery and apprehension, and/or by use of force, deception, and threat, prevent and obstruct anyone from performing an act that might aid in the discovery and apprehension of such person, and/or conceal, alter, and destroy physical evidence that might aid in the discovery and apprehension of such person, and/or provide such person with a weapon; contrary to Revised Code of Washington 9A.76.070(1)(2)(a) and 9A.76.050.
